Statement Pursuant to Section 19(a) of the Investment Company Act of 1940

On October 1, 2025, the Octagon XAI CLO Income Fund (the "Fund") paid a distribution on its Class A and Class I shares of \$0.15950 and \$0.16670 respectively, per share to shareholders of record at the close of business on September 29, 2025. Under U.S. generally accepted accounting principles (GAAP), the Fund estimates that 95.54% of the distribution is attributable to current year investment income and 4.46% is attributable to return of capital.

The figures noted above attempt to provide an estimate of the sources of distributions based on net cash flows received from portfolio securities. The ultimate composition of the distribution may vary from the estimates provided above due to a variety of factors, including amortization, future income and expenses, and realized gains and losses from the purchase and sale of securities.
