The Fund's investment objective is to is to achieve long-term capital appreciation through a Objective: strategically managed portfolio that provides investors with exposure to venture capital and

private equity investments.

The Fund will seek to achieve its investment objective primarily through investing in equity securities (e.g., common stock, preferred stock, and equity-linked securities convertible into equity securities) of private, operating companies, which are expected to include mid- and latestage venture-backed companies and middle-market private equity-backed companies, (collectively, "Portfolio Companies") often in the technology investments in sports, defense, space, and healthcare sectors. The Fund anticipates acquiring interests in Portfolio Companies both directly from the issuer, including through co-investing with other venture capital and private equity funds and other investors, and, to a lesser extent, from third party holders of these interests in secondary transactions. While not a primary strategy, the Fund anticipates that it may also, to a lesser extent, invest Fund assets in professionally managed private venture

capital, private equity, and real estate funds ("Portfolio Funds"), and make direct or indirect investments in real estate and real assets. For liquidity management or in connection with implementation of changes in asset allocation (including following liquidation of an investment) or when identifying private investments for the Fund during periods of large cash inflows or otherwise for temporary defensive purposes, the Fund may hold a substantial portion of its assets in cash or cash equivalents, liquid fixed-income securities and other credit instruments, publicly-traded equity securities, mutual funds, money market funds, and exchange-traded funds. Although the Fund intends to primarily target investments in the United States, the Fund

has the flexibility to invest across varying geographic regions and industries.
