| <b>Strategy:</b>                          | The Fund intends to pursue a hedged equity investment strategy by (i) investing primarily in U.S. exchange-traded equity securities contained in the S&P 500® Index (such index, the "Reference Index"), (ii) mitigating some of the risk of loss of principal by purchasing a potentially limited hedge against the Reference Index ("Downside Hedge"), and (iii) producing income with a target net income objective of 12.0% on an annual basis ("Defined Income"). The Reference Index is a price return index that does not reflect the reinvestment of dividends. The Fund will forgo potential capital appreciation as it seeks to generate income. The Downside Hedge is designed to mitigate the risk of loss for those investors that buy Shares at the beginning of a three-year period (the "Designated Period") and hold Shares until the end of the Designated Period. |
