To a lesser extent, the Fund may invest in other CLO debt securities, CLO equity or other debt securities as consistent with our investment objectives. A portion of CLOs in which the Fund invests may be backed primarily by loans to middle market companies (or hold significant portions thereof). The Fund may also invest in other related securities and instruments or other securities and investments that the Adviser believes are consistent with the Fund's investment objectives, including, but not limited to senior debt tranches of CLOs, loan accumulation facilities, securities issued by other securitization vehicles (such as gradit linked notes, collateralized band obligations, and revelver CLOs), corporate

(such as credit- linked notes, collateralized bond obligations, and revolver CLOs), corporate bonds and synthetic investments, such as significant risk transfer securities and credit risk transfer securities issued by banks or other financial institutions. These opportunistic investments may also include, without limitation (i) debt and equity securities issued by business

development companies, (ii) direct investments in Senior Secured Loans, (iii) fixed income securities and (iv) private investment funds that provide exposure to Senior Secured Loans and fixed income securities. With respect to the foregoing investments, Fund's general investment strategy is broad and is not limited to any specific industry, sector, or a minimum or maximum

market capitalization.
