| <b>Strategy:</b>                        | <p>We seek to achieve our investment objectives by investing primarily in third party CLO equity and mezzanine tranches of predominately U.S.-dollar denominated CLOs backed by corporate leveraged loans issued primarily to U.S. obligors. This investment strategy looks to opportunistically shift between the primary and secondary markets, seeking to identify the most compelling relative value. Our focus is on the primary market when the arbitrage between assets and liabilities is attractive and will switch to the secondary market during times of market volatility or when we identify attractive opportunistic and idiosyncratic trades. The Adviser aims to identify top-tier CLO managers with proven track records of outperformance through par building, high equity cashflows and active portfolio management. Additionally, the strategy is focused on attractive deal structures which include manager flexibility, strong cushions on deal covenants and cashflow ratios, equity-friendly terms and reinvestment periods that fit market views.</p> |
